

****For a smooth ACA policy placement experience, it is essential to read all informational documents and emails provided by ART Risk.****

ART Risk is NOT an insurance company. ART Risk IS an insurance brokerage assisting you and your Intended Parents with an ACA insurance policy application. This new insurance policy will be used for your journey.

WHAT TO EXPECT:



ART RISK WILL BE CONTACTING YOU

- After the insurance policy for your journey has been decided, ART Risk will contact you from a 661 area code via phone or text.
- At this time we will schedule your 30 min. phone appointment with one of our Dedicated Agents to apply for your policy.



DURING THE INITIAL CALL, WE WILL VERIFY

- Your personal information to apply for an ACA insurance plan
- The preferred Provider information (OB and hospital) we have on file is accurate **TIP: Discuss this in advance with your IPs/Agency*
- That your agency and/or IPs have informed you how the insurance binder payment will be paid. (We suggest you discussing this in advance with your agency/IPs)
- If you have been selected to be placed on an Anthem CA policy, we recommend you reading [this information](#).
- If you have any other medical insurance policies in your name, including Medicaid and Tricare



PREPARE FOR YOUR APPLICATION APPT

- Allot 30 minutes for the application appt to be completed with an ART Risk licensed insurance Agent via phone call
- If it has been determined that you are paying for the first month's Premium during the application appt., have the payment method and funds ready
- Text a photo of your driver's license in advance of the appointment if instructed by our staff during the initial call/text

We recommend doing your research and providing your preferred OB and hospital to your agency and IPs right at the beginning of your journey. Even if it hasn't been finalized if you are needing an ACA policy, best practice is to make sure your agency has this info on file.

If you are on Medicaid or Medi-Cal, we recommend making a 15 minute phone appt. with your ART Risk assigned Agent. They can walk you through the phone call to Medi-aid.

Because Medi-aid is income based, it is best to contact them directly after speaking to one of our agents who will give you the info to ask Medi-Caid.
