OWN PATENT POLICY HIGHLIGHTS

EFFECTIVE DATE	Medication Start Date or Application Date, whichever comes last. Once Injectable medications have started, the Policy is no longer eligible for application.
MAXIMUM LIMITS OF INDEMNITY	This is the maximum aggregate amount of money that will be paid under the policy for Medical Expenses related to complications.
TERMINATION DATE	Please refer to the Policy Certificate for the Policy you are purchasing for full Termination Date clause.
CANCELLATION PROVISIONS	Policy is non-refundable once medications have been taken. A refund will only be given if NEW LIFE AGENCY is notified of the cancelation request: either prior to the reported cycle medication start date, or up to two (2) weeks after the reported cycle medication start date with a signed letter from the treating IVF Clinic confirming no medications were taken.
ADDITIONAL RIDERS	Reproductive Organ Loss rider and Lost Wages rider may be added to the Policy.
TRAVEL CONDITION	No air travel within 24 hours of the procedure and no ground transportation travel of over 4 hours within 24 hours of the procedure
EXCLUSIONS	• Pre-existing conditions. • Failure to follow a healthcare professionals' direction • Nervous or mental disorders. • Procedures, testing or medical choices solely for the convenience or at the request of the Insured or Oocyte Donor or Recipient or Surrogate. • Any Medical Expenses incurred at Kaiser or Sutter facilities. For full list of exclusions and conditions of the Policy you are purchasing see Policy Certificate.
APPROVED PROVIDERS	For medical treatment by an Approved Provider, the Policy will pay one hundred percent (100%) of Reasonable and Customary covered Medical Expenses up to the Maximum Limits of Indemnity for covered Medical Expenses.
NON-APPROVED PROVIDERS	For medical treatment by a Non-Approved Provider, the Policy will pay sixty five percent (65%) of covered Medical Expenses or the Reasonable and Customary amount allowed for the services provided, up to the Maximum Limits of Indemnity. The remainder of the Claim will be Co-Insurance.

NEW LIFE AGENCY does not work with or pay claims to Kaiser Permanente Providers and Sutter Providers. If claims are incurred at these facilities, NEW LIFE AGENCY will not be responsible for payment, unless in a Life and Death emergency.
