Newborn Insurance: • Professional Administration and Consultation Fee (ACA) - Domestic Only • ACA Newborn Policy • Specialty Newborn Policy	\$625 for Domestic IPs only \$10K-\$15K (Insurance Premium + OPM) \$12,000-\$22,500
